EXHIBITOR REGULATIONS

November 29 & 30 2019

1. Event

Nationale Dagen Duivensportbond NPO 2019 in **De Beursfabriek, Nieuwegein.**

2. Public opening times

- Friday November 29 from 15.00 until 21.00
- Saturday November 30 from 09.00 until 17.00

3. Exemption Store Closing Act

This exemption has been granted by the municipality of Nieuwegein to De Beursfabriek for free stand sales of branch-related articles and products related to pigeon sport. Exhibitors who wish to trade or sell racing pigeons directly must submit a separate request in this regard to the Trade Coordinator - NPO National Days, p / a Bureau NPO, in Arnhem.

4. Supply and removal of stand material and goods

Use of the service entrance:

- Wednesday 27 November from 8 a.m. - 9 p.m.
- Thursday 28 November from 8 a.m. - 9 p.m.
- Friday, November 29 from 8 a.m. - 3 p.m. **Please note: strict checks from 1 p.m.**
- Saturday, November 30 from 7.30 am to 8.45 am **Please note: strict control**
- Saturday 30 November from 5 p.m. - 10 p.m.
- Sunday 1 December from 8 a.m. to 5 p.m.
- Monday 2 December from 8 a.m. to 11 a.m.

Stands that have not been demolished on Monday at 11 am will be removed by De Beursfabriek staff.

Parking of trucks after unloading is permitted in the parking lot. With construction and dismantling there is no access for cars to load and unload in the hall!!!

5. Rental price stand space (ground surface)

The rent is € 70 per m². This price does not include VAT.

6. Electricity

On the registration form, you can indicate what the need for electricity is.

7. Reservations

Registration forms for stand space and stand construction must be in our possession no later than 8 November. A reservation can only be honored if the direct debit authorization form has been completed and signed.

8. Parking

Parking is free. Therefore, no parking tickets are sent. All cars of the exhibitors can be parked in the parking lot.

Only exhibitors and exhibitors' staff have access to the parking spaces next to the building.

9. Stand construction and layout/furnishing

Wednesday, November 27 from 8 a.m. - 9 p.m.: The stands can be set up and set up between these times.

Thursday, November 28 from 8 a.m. - 9 p.m.: Between these times, further construction and layout of the stands is possible. In the evening visitors are admitted to the building who send in their pigeons for the national exhibition, so keep this in mind.

On Friday, November 29, between 8 a.m. and 3 p.m. can be arranged.

Pay attention! The first reception of guests will take place from 12:00. The official opening is at 3 p.m. All stands must then be fully furnished and tidy.

10. Stand materials

To place your stand, you can also rent a stand via the NPO and request a quote for it. Under the instructions of the fire brigade, highly flammable materials may not be used, such as paper, cardboard, corrugated cardboard, straw, wicker mats, textiles, etc. Impregnated textiles may be used. Overhanging cloths, if impregnated, must be at least 10 cm free from the floor. Also, by order of the fire department, all rented places must be delimited by fixed walls. Furthermore, in all cases the fire department regulations must be strictly followed.

11. Layout stands

The places are allocated in order of receipt of the reservation forms until the available stand space is fully booked. The standing depth is generally 3 meters and the permitted height is 350 cm. **If higher, please contact the trade fair coordinator, Mr. Leo Heesakkers, GSM: +31 (0) 6-13437374.** To a limited extent, a position depth of 2 meters or 5 meters is possible. The space available for this is allocated in the order of registration. If the limit is reached, a depth of 3 meters is automatically assigned for further requests. The stands are placed sideways against each other with a common front line of which may not be deviated from. No goods, packaging and suchlike may be stored behind, beside or in front of the stands.

12. Restrictions on exhibitors

Exhibitors are not permitted to draw attention to their company name or product in any other way outside the stand space by means of banners, posters, the distribution of brochures, brochures, pamphlets and the like or the sale of articles and products, without permission from the organization.

The use of audio and video equipment within the stand is permitted, this is to be noted assessment of the organization. **These restrictive provisions apply both inside and outside De Beursfabriek to the corresponding parking area and also apply to non-exhibitors.**

13. Liability

The NPO cannot be held liable for theft of products or pigeons. Participation is entirely at your own risk, the organization is not liable for damage, caused in any way. The exhibitor must also have taken out liability insurance himself.

14. Further information

All exhibitors will receive a map of the exhibition hall via e-mail, on which the allocated locations are registered. It is no longer possible to deviate from the final ranking.

15. Exceptional situations

Where these regulations do not provide, the NPO Nationale Dagen Tradefair Coordinator Leo Heesakkers, decides on behalf of the NPO Board.
